

Research briefing: levels of traffic police 2008-2012 in GB



Aims:

To determine the number of police officers that work in traffic enforcement in each police force in England, Wales and Scotland, how these levels have changed in the past five years and expectations for levels in the near future.

Methods:

Building on the results from its 2011 Freedom of Information requests to police, Brake contacted the 51 police forces¹ in Great Britain to ask them to supply numbers of traffic police officers in the force in March every year from 2008 to 2012. For some forces, Brake already held information of traffic police numbers for 2008-2011. In these cases we requested only the information not already held.

Results:

The results show that traffic policing continued to fall in England and Wales, with a drop of 14.29% over the past five years, including a drop of 4% in 2011-12 alone. In Scotland numbers of traffic police increased in the same five year period.

All but one of the 51 police forces across Great Britain replied to Brake's Freedom of Information request, but only 46 were able to provide complete responses. To ensure proportionality, incomplete responses were excluded from calculations of percentage change in traffic policing in the past five years. Incomplete responses are not shown below, and not included in country and regional calculations. A list of forces with incomplete responses can be found below.
